- 3. Public Comment: None.
- 4. <u>Consent Agenda Items</u>: Motion to approve the Minutes of the May 17, 2017 Regular Board Meeting was made by Trustee Caraveo and seconded by Trustee Wisniewski. Motion carried.
- 5. <u>Branch Manager Report Kathy Totten</u>: Kathy reports the Bookmobile has been out in the community a bit more other than their regularly scheduled stops. They visited the Justice Center on take your child to work day with 150 visitors. The Bookmobile was also in the Commerce City Memorial Day Parade. She shared an article about the Bookmobile. 8. <u>Anythink Strategic Planning Update – Steve Hansen</u>: Steve gave a visual overview of results from the community Roundtables held so far and what's ahead.

In July branch staff will be conducting 60 second walk in customer surveys, the survey is also on our website.

Pam is currently circling back and meeting with branch staff to gather new updated innovative ideas.

There are two open community meetings scheduled at WF & Huron Street.

August 1-16 the team will review and analyze the data gathered, a conversation with the Board will be held at the August 16 meeting.

In September the team will draft the Strategic Plan.

The re-scheduled dialogue on public libraries will be held on September 11.

The draft of the strategic plan will be available for the Board to review at the October 18 meeting and the final draft will be presented at the November meeting for Boards approval.

Pam, Staff and two Interns from CC attended the PLA conference in D.C. The interns came away with amazing ideas for projects.
